## Waiver and Release

This release extends to any and all claims I have or later may have against the “Released Parties” resulting from or arising out of the “Released Parties” performance of their duties whether or not such claims result from negligence (except for willful neglect) on the part of any of the “Released Parties” with respect to the Event or with respect to the conditions, qualifications, instructions, rules or procedures under which the Events are conducted or from any other cause, expressly including the actions or omissions by other participants in the Event whether or not such action or omission was in the control of the “Released Parties”. I understand that this means that I agree not to sue any one or all of the “Released Parties” for injury or damage resulting to myself (whether mental or physical) or my property arising from, or in connection with the performance of the “Released Parties” duties in planning, sponsoring or conducting the Event. Further, I acknowledge that participating in a motorcycle “Run” is potentially hazardous and that I should not participate unless I am medically able, properly trained and riding a vehicle that is in good working order and meets the standards established by the Commonwealth of Massachusetts for vehicles licensed to operate on public streets and motorways. I assume all risks associated with participating in this Event including but not limited to falls, contact with other participants, weather, traffic and conditions of the road, all such risks being known and appreciated by me. By signing this release, I certify that I am over the age of 18 (or have attached a signed parental release to this form), have read and fully understood this release and that I am not relying on any statements or representations made by the “Released Parties” regarding this Event or its sponsors.
